- Commissioner Cuthbert Explain abate water problems? There are neighboring residents
  having water pressure and other water problems with construction and want help with costs to
  fix.
- Phillip Pannell What is the committee's definition of senior citizen? 50 years old and up –
   Same as AARP
- Phillip Pannell I would hope any benefits available for seniors would be available for those with disabilities as well. Yes.
- Sandra Seegars Are the bike lanes outside or inside? Outside
- Darnetta Tyus Is the shuttle service the same as the Escort Transportation? No, it would be to get seniors to various facilities in the Ward.
- Darnetta Tyus Will we go back and assess which needs can be addressed with existing services? For example, there is a state of the art aquatic facility at Barry Farms Rec that is Free.
   Yes, but there is no place to park
- Hillary Brown Will these parking spaces be free to residents? Parking is a function of zoning.
   They will identify the need based on the design.
- Martine Combal (DMPED) We are working with CH2M on a parking study to determine the allocation of parking across the Campus. We are developing an interim and a long term parking plan. We are also looking at the feasibility of building a parking structure. Our contractor is currently going out and collecting parking data during events in the area. They are also looking at existing parking in the area. Once the data collection and some analysis has been completed, DMPED will present to the community before completing the final report in November, which will ultimately provide a series of recommendations.
- We are working with CH2M on parking to allocate more to the ESA. We are investing an interim plan and a long term plan. We are looking at the feasibility of building parking. We need to look at costs too. Our contractor is currently going out and collecting parking data during events in the area. They are also looking at existing parking in the area. We need to figure out what the solution will be.
- Monica Ray During Ms. Seegars meeting, they also asked about better enforcement of parking during events.
- Sandra Seegars If your people take up neighborhood spaces, and we get a ticket because we have to park by the fire hydrant, we want your people to pay the ticket. Martine Combal (DMPED) We will investigate and figure out the best solution. Before the solutions are finalized we will come back and get community input on the recommendations.
- Sandra Seegars in SW near the stadium, they do have parking that says no parking during events for non-residents but I don't know how that works
- Commissioner Muhammad ANC 8E is in the process of changing the parking restrictions to Ward 8 only on the South side of Alabama Ave from 1100 block to the 1300 block and calling every day because there is no enforcement on the north side of Alabama Ave that says no parking anytime. They park all day for free.
- Guleford Bobo At the ANC meeting they said there would be enforcement at the Broccoli
   Festival and I didn't see any. I live on Alabama Avenue and couldn't access to our homes
- Sandra Seegars I was able to call the police during Broccoli Fest and they came late but did
  issue 24 tickets.
- Shirley Price During your assessment with CH2M, are you having a community advisor with that group? The opportunity for community input will be in September when we come back.

- Darnetta passed out a one pager on the parking study so you know what it includes.
- Connie Spinner We asked for things that will increase the problems we are talking about. For example, if you want a skating rink, you're going to have parking problems. As we think about how we will narrow the field, we think about how we maximize what we have EOR.
- Yvonne Peterson Asked a question about parking during a church event outside of the affected area. They asked that it be brought up at the ANC 8B meeting.
- Phillip Pannell The thrust is to deemphasize the use of cars, so talking about increasing parking spaces is probably not very realistic
- Sandra Seegars What type of parking will they have during construction for workers? Martine Combal (DMPED) will have to get back to you.
- Sandra Seegars We also had a mailbox system for the homeless on the grounds
- Connie Spinner How many items should we narrow to? 3? 5? You should narrow it down to 5.
   You should think of the top 3 things you want and 2 alternatives in case they are not possible.
- Kevin Vaughan Back to the formula, is what is left what goes to CBA? Not necessarily, it is a very fluid process today. All 3 buckets will need to equal \$55M. Pete Kirschner (Events DC) it's still in development process. The budget is set for the whole project so all 3 buckets will equal \$55M. With DMPED, the architect, the community, etc. figuring out how the \$55M will be allocated.
- Darnetta Tyus There is an opportunity to use what is existing. There is a computer lab in this building. We can identify where existing resources can be used and not try to make this particular facility the answer to world peace. Monica As an example, a component of this CBA could be some dedicated days in this lab that this community can use as a free lab space. Darnetta And access to Barry Farms Aquatic Center could be an issue of transportation and a shuttle vs. building another.
- Guleford Bobo If we go over our budget, will the Community Benefit budget get cut? No, the CBA will be in place and won't be affected.
- Sandra Seegars Will there be traffic study for trucks, etc.? There should be a Traffic Control Plan to do so.
- Monica Ray It is important to remember step 10 Implementation, Monitoring and Enforcement to ensure everyone is operating within the four corners of this agreement. Once this CBA is signed, the community's role is to support the project but it's also the other party's job to do what they promised.
- Connie Spinner- I agreed to be a part of this process because for the first time since I remember the developer didn't go off and create their own community benefits package. They did a very open and transparent process that gives us a chance to really be a part of it. I don't want us to get so caught up in trying to solve all of the problems that we miss our opportunity to really contribute in a meaningful way to this and we get so nitpicky that we end up with nothing that helps anybody.

Monica explained that we will look at similarities and

<u>Existing CBAs Review:</u> We reviewed 3 existing CBAs because people have asked us for examples. We reviewed the DC United Soccer Stadium, St. E's Phase I Redevelopment with Redbrick and Whole Foods (965 Florida Ave). The slides are attached with the details.

- We discussed the length of the contract, the value of the CB agreement vs. total project and the ability to renew at the end of the contract
- We also shared the terms listed in each agreement
- Pocket Park was mentioned in one of the agreements Ms. Seegars asked what a pocket park was? It's a park inserted between existing structures.
- There were synergies between some of the wish list items but they had quantified what they would look like
- S.V. Williams Will you send us these slides? Yes, and we are looking at how we will share documents for people moving forward. We will email this.
- Phillip Pannell What was the make-up of the group who put together the DC United Agreement? They were similar to this group but ward 6 residents. They were called Community Benefits Coordinating Council
- Kevin Vaughan I noticed in some of the contracts the focus area was a mile radius around the facility, we haven't defined the project area. Maybe we should decide that in our agreement.
- Commissioner Muhammad We will negotiate the length of the contract in our agreement. The enforcement of the tax abatement for one year won't help residents.
